Thank you for notifying our office of the proposed construction of 60 multi-family housing units within the Caldwell Labor Camp, Caldwell, Idaho. The housing will be located in Section 9, T4N, R3W. Before we can review this project for archaeological concerns, we will need some additional information. Please provide general photographs showing several views of the proposed housing location. As well, we will need a description of past disturbances to the ground within the project area. For instance, has the area been leveled or modified using heavy equipment?

Once we receive this information, we can continue our review. Depending upon the degree of disturbance, we may recommend an archaeological inspection of the project area.
